WE WANT TO WORK TOWARDS A FUTURE WHERE EVERY VETERAN, EVERY DOG, CAN LIVE WITHOUT ISOLATION. P&S USES A UNIQUE CURRICULUM TO NOT ONLY OWNER CO-TRAIN VETERAN DOG TEAMS, RESULTING IN A FULLY TRAINED SERVICE ANIMAL AFTER 9-12 MONTHS, BUT ALSO TO INTEGRATE MENTAL HEALTH SUPPORT FOR BOTH THE VETERAN AND THE FAMILY FROM START TO FINISH.
